Dear Parents/Guardian,
Greetings from Mount Carmel School, Chandigarh!

Further to the numerous School Notices sent in the years 2022 & 23, **you are once again advised to clear the outstanding fees due as per the fee schedule notified by the School (including arrears), in respect of your child immediately.**

In this regard kindly note the following:

1. The Hon'ble High Court of Punjab & Haryana had dismissed the CWP-9840-2021 (O&M) titled Manpreet Kaur and others (Petitioners) Versus Chandigarh Administration and others (Respondents) vide Order dated 03-02-2023. Pending application (s), if any, were also disposed off in view of the aforesaid Order.
2. After the above said Order of the Hon'ble High Court of Punjab & Haryana, a handful of Parents had approached the Regulatory Body for Regulation of Fee of Un-Aided Educational Institutions, in Chandigarh, with false and baseless complaint regarding the School Fee. We wish to remind you that since 2017 these handful of Parents have been trying their best to mislead the media and the Hon'ble Courts by presenting fabricated figures regarding the School fee, totally based on falsehood.
3. **The Regulatory Body for Regulation of Fee of Un-Aided Educational Institutions, in Chandigarh, vide its Order, dated 22-04-2024, has clarified that the School has complied with the orders of the Hon'ble Supreme Court and the Chandigarh Administration and collected same fees for the session 2020-21 as was collected for the session 2019-20 but by providing 15% deduction on that amount.**

Hence vide this Order the Fee Regulatory Body for Un-Aided Educational Institutions of Chandigarh, under the Chairpersonship of the Education Secretary, U.T., Chandigarh, has REJECTED the complaint filed by these handful of Parents.

By this communication we wish to bring to your kind notice that since 2017, very unfortunately these handful of Parents in order to gain cheap popularity have been opposing the policy of betterment in imparting quality education by the School. As you know, for this purpose they had even tried to mislead the media and the Hon'ble Courts by presenting fabricated figures regarding the School fee, totally based on falsehood.

We would like to emphasize here that Mount Carmel School, Chandigarh has a standing of over 38 years of imparting quality education and is one of the well known institutions of the City Beautiful. Our students have achieved great heights in both Scholastic and Co-scholastic fields and many of them are very well placed in Society. **We believe "If God be for us, who can stand against us".**

Please Remember that children are impressionable and always learning. Children learn what they live:
If a child lives with criticism, He / She learn to condemn.
If a child lives with hostility, He / She learns to fight.
If a child lives with tolerance, He / She learns to be patient.
If a child lives with Criticism, He / She learns to condemn.

All the above orders are self explanatory and leave no room for any ambiguity.

This is therefore to once again reiterate that fees due as per the fee schedule notified by the School, in respect of your child be cleared without any further delay at the earliest, failing which action will be initiated as per the School rules. If your child is studying in this School it becomes your utmost responsibility to pay the fees and clear your dues towards the School in time.
